Spring is here ! Doing spring cleaning? Don't forget any discarded items that don't fit in a 55gal drum needs a \$50 bulk Item permit.

Leaf and brush must be dumped in designated pile and must not be in plastic bags .
(See schedule of fines for all dumping information and fines.)

Remember the following all need permits, they take up to 15 days for approval from ECO and Last 3 months .(Approved permits must be posted at the property.

*Painting, Staining , Gravel or Re-gravel .

*All Tree even under 3in diameter need an approved permit for removal.

For every tree taken down a new tree must be planted .

All above permits are no Charge.

*New Structure such as

Decks, Sheds, gazebos , Florida rooms, BBQ bump - outs and golf cart ports .

Check the governing documents and consult the ECO before planning on any builds or improvements.

The ELCA permit fee is \$75 for all new structures. Covington Township charges a fee between \$50-\$100 for all new structures. Both the ELCA and Covington Township fees are per structure.

Please note these fees are subject to change.

Recommended Trees for Planting and Ideal Planting Times

As we prepare for the upcoming planting season, we would like to offer some helpful information on the best trees to plant in the northeastern part of Pennsylvania. Planting trees that are well-suited to our climate and soil conditions will ensure their success and contribute to the beauty of our community for years to come.

Here are some tree species that thrive in our region:

Red Maple – Known for its brilliant fall color and ability to adapt to a variety of soil types, the Red Maple is a great choice for both shade and ornamental purposes.

Eastern White Pine– A fast-growing evergreen, this tree provides year-round beauty and serves as an excellent windbreak.

Sugar Maple– Famous for its stunning fall foliage and maple syrup production, the Sugar Maple is perfect for larger yards and spaces.

American Holly– A hardy evergreen with glossy leaves and red berries that add color throughout the winter months.

Dogwood– Known for its beautiful spring blooms, the Dogwood is a small ornamental tree that thrives in shaded areas.

Ideal Planting Times:

The best time to plant trees in our area is during the early spring (April-May) or fall (September-October). These seasons offer moderate temperatures and ample moisture, which promote strong root development before the heat of summer or the cold of winter sets in.

Avoid planting trees in the peak summer months, as the heat can stress young trees and hinder their establishment.

We encourage you to consider planting native trees or those well-adapted to our region, as they will provide the greatest benefit to our local ecosystem and community.

If you are cleaning up your leaves, do not leave them along any **Eagle Lake roads**. Also, please do not blow leaves onto your neighbor's property as a means of disposal—both actions are prohibited and will result in citations.

Please dispose of your leaves behind the tennis court in the designated area.

Ditches and Swales

Property Owners are responsible for any **ditches and swales** located on their own lot; this includes the drainage ditch and/or culvert pipe located at the end of your driveway. Drainage ditches and swales need to be kept clean and free of debris for maximum water flow and drainage. Property Owners are welcome to contact a Contractor to maintain these areas.

Laundry Room Reminder

Due to machines being high efficiency (HE), they use less water than normal. In order to better facilitate your wash, **DO NOT use laundry PODS of any sort.**

Machines are restricted to liquid and powder detergent. The PODS are not dissolving immediately during your wash cycle and is causing residue on clothing or left behind in the washer after use. Also, please remember to leave your credit card in the machine and follow the prompts, do not remove until you are instructed to do so.

Beach 2 Parking

After dusk, all vehicles and golf carts park with the tail-end of their vehicle lake-side and lights should be turned off in the Beach 2 parking lot. There have been new signs posted to explain procedure.

Each property in the Eagle Lake Community Association “ELCA” is intended to be used for camping purposes.

ELCA is located in an MP-RV (Mobile Home Park – Recreational Vehicle Park District) zone, within in Covington Township, Pennsylvania. As stated in your deed, “Covington township prohibits the use of the land being conveyed hereunder as a residence within the meaning of the Pennsylvania school code and the land being conveyed hereunder shall only be used for recreational purposes.”

The *Eagle Lake Deed Restrictions* (or [restrictive covenants](#)) includes multiple definitions as it pertains to your ELCA lot as a campsite/campground lot.

The following is section III of the *Eagle Lake Deed Restrictions*, which details land use.

III. LAND USE

3.1 Campsites unless otherwise provided in this Declaration, Campsites shall be used only for camping purposes. Owners of Campsites may place thereon Recreational Vehicles or Tents and any related facilities as may be approved by the Committee.

Exceptions may be approved by the Committee. No Improvements or any mobile home designed for permanent occupancy may be erected or placed on any Campsite. All Recreational Vehicles in the Development shall be maintained in a transportable condition at all time.

No Campsite shall be occupied on a permanent basis and no Campsite shall be the primary and principal residence of the Owner, or any other occupant thereof, it being the express intention hereof that each Campsite be used and occupied for camping and recreational purposes only by a single Household. School-aged children cannot be sent to school from Eagle Lake and Eagle Lake cannot be used as a permanent address for school registration purposes. The Committee may require any Owner to remove a Recreational Vehicle for a period of 24 hours, unless each Owner can establish a prior removal within the immediately preceding 12 months.

The properties, and permitted *temporary living quarters* within the community, are **not** intended for year-round occupancy. The Eagle Lake Community Association, by way of its Directors and Management staff, will enforce the campground atmosphere, and does not condone or permit permanent residency within the community. Methods of prevention and enforcement can, and will be, utilized in the event a property is suspected to be occupied for 12 or more months, consecutively.

Collection System Markers

As part of the Lift Station Rehabilitation Agreement, ELCA has begun Collection System Study. Upon Completion of this study, ELCA will be provided mapping of the entire collection system and data sheets for each Lift Station on property which ELCA currently does not have. The evaluation has been mandated by PADEP as part of our amended Consent Order and Agreement and must be completed for ELCA to move forward with the Lift Station Rehabilitation project.

As some have noticed, there are green stakes and flags located throughout the Community along the side of the roads. These markers are identifying the location each manhole throughout the Community and their purpose. DO NOT move the markers, as it will cause complications for the firms completing field work for the study.

Manhole Marker Notice

The manhole evaluation has created a few very deep potholes throughout the community. Some ELCA manholes are located a foot underneath roadways due to years of being covered over with road material. The operations team is currently looking into options to raise the manholes and mitigate the holes in the roadway.

As a reminder:



Property owners should never remove or relocate any emergency cones or signage used to identify the pothole.



Travel within ELCA abiding the speed limit and be aware of current road conditions.

SPRINGTIME ALERT: LEAVE YOUNG WILDLIFE ALONE

HARRISBURG, PA - Whether in their backyards or high on a mountain, it's almost certain Pennsylvanians will encounter young wildlife this time of year.

While some young animals might appear to be abandoned, usually they are not. It's likely their mothers are watching over them from somewhere nearby.

So, when encountering young wildlife, be it deer, birds, raccoons or other animals, the best thing you can do is leave it alone.

"Well-intentioned people might step in to help a young animal that appears to be alone, not realizing its mother is nearby and it's not in need of help," said Matthew Schnupp, the Game Commission's wildlife management director. "That's one reason why leaving young wildlife undisturbed in the wild typically is the best solution when encountering young wild animals."

Adult animals often leave their young while they forage for food, but they don't go far and they do return. Wildlife also often relies on a natural defensive tactic called the "hider strategy," where young animals will remain motionless and "hide" in surrounding cover while adults draw the attention of potential predators or other intruders away from their young.

Deer use this strategy, and deer fawns sometimes are assumed to be abandoned when, in fact, their mothers are nearby.

The Game Commission urges people not to interfere with young wildlife or remove any wild animal from its natural setting.

Such contact can be harmful to both people and wildlife. Wild animals can lose their natural fear of humans, making it difficult, even impossible, for them to live normally ever again in the wild. And anytime wildlife is handled, there's always a risk people could contract diseases or parasites such as fleas, ticks and lice.

Wildlife that becomes habituated to humans also can pose a public-safety risk. Some years ago, a yearling buck attacked and severely injured two people. An investigation revealed a neighboring family had illegally taken the deer into their home and fed it as a fawn, then continued to feed the deer right up until the time of the attack.

It is illegal to take or possess wildlife from the wild. Under state law, the penalty for such a violation is a fine of up to \$1,500 per animal.

Under no circumstances will anyone who illegally takes wildlife into captivity be allowed to keep that animal, and under a working agreement with state health officials, any "high risk" rabies vector species confiscated after human contact must be euthanized and tested; none can be returned to the wild because the risk of spreading disease is too high.

Animals infected with rabies might not show obvious symptoms but still might be able to transmit the disease. Though any mammal might carry rabies, the rabies vector species identified in the agreement are skunks, raccoons, foxes, bats, coyotes and groundhogs.

People can get rabies from the saliva of a rabid animal if they are bitten or scratched, or if the saliva gets into the person's eyes, mouth or a fresh wound.

Only wildlife rehabilitators, who are licensed by the Game Commission, are permitted to care for injured or orphaned wildlife for the purposes of eventual release back into the wild. For those who find wildlife that truly is in need of assistance, a listing of licensed wildlife rehabilitators can be found on the Pennsylvania Association of Wildlife Rehabilitators website, www.pawr.com.

If you are unable to identify a wildlife rehabilitator in your area, contact the Game Commission by phone at 1-833-PGC-WILD or 1-833-PGC-HUNT.
